



GUIDELINES FOR REPRODUCTION AND USAGE OF LEADINGRE SALES VOLUME BAR CHARTS

We have created an extended version of our bar chart with additional competitors. You may choose the one that is most appropriate for your market.

- 1. Charts must always reflect membership/affiliation with the LeadingRE network, rather than implying that the bar chart applies only to your individual brokerage.
- 2. Charts should be used as graphic support but may not be used free standing without proper language from headline or subhead.
- 3. Charts must always include dated disclaimer source information and correct dollar figures on each competitor bar.
- 4. Bars or sectors of the charts may not be removed to exclude competitors.
- 5. Member name may only be included on bar or sections of the charts if LeadingRE is included as part of the name: "... Member of LeadingRE," "...Network member" or "LeadingRE Affiliate..."
- 6. Charts must include appropriate scale and may not be recreated, relabeled or rescaled without LeadingRE approval.
